2. Candidates who have a valid CUET (PG)-2023 (COQP12) score but have not filled the registration form of Mahatma Gandhi Central University will be given 2<sup>nd</sup> preference\*.
3. If the seats still remain vacant, the candidates who have not given the CUET (PG)-2023 exams will be given 3<sup>rd</sup> preference\* and admission will be made on the basis of composite score.

The composite score will be determined as follows:-
